**SELECTION OF TREATMENT AREAS:** Determine areas where mice will most likely find and consume the bait. Generally, these areas are along walls, by gnawed openings, beside burrows, or in corners and concealed places.

**APPLICATION DIRECTIONS:**

Place single BOX unit at intervals of 8 to 12 feet along walls or in corners where mice or signs of mice have been seen. Replace BOX units if their contents are consumed or contaminated, or if the units are severely damaged. Units not touched after three days should be moved to new locations where mouse activity is evident and units can be placed without violating the requirements of this label.

Collect and dispose of all dead animals and leftover bait properly. To prevent reinfestation, limit sources of rodent food, water, and harborage as much as possible. If reinfestation does occur, repeat treatment.
